**The CHG-MERIDIAN Group has been awarded the Platinum Medal in the latest EcoVadis rating, placing it among the top 1 percent of more than 130,000 companies assessed worldwide. This result highlights the company's consistent advancement of its sustainability management.**

Building on the Gold Medal achieved in 2024, CHG-MERIDIAN made another significant leap forward: the company increased its overall score by ten points to 86, earning the highest distinction – Platinum. The strongest ratings were achieved in the categories of Environment and Business Ethics.

A key factor behind this improved result was the expansion of ISO certifications across all European locations in December 2024, which has now been reflected in the current rating. This means that management systems in the areas of Environment (ISO 14001), Information Security (ISO 27001), Data Protection (ISO 27701), and Business Continuity (ISO 22301) are now valid across Europe. In addition, the Compliance Management System (ISO 37301) was certified for the first time in the DACH region. Complemented by extensive global training initiatives, these measures further strengthen the company's international competitiveness and underline CHG-MERIDIAN's high standards of quality and sustainability.
